

EXCESS OF LOSS POLICY

SUM INSURED: Up to USD 1,000,000 per Claimant, subject to and in accordance with the limits and the terms and conditions of the Policy.

RETENTION: In respect of each Claimant the sum of all Distributions and Deemed Distributions pertaining to that Claimant, subject to a minimum of USD 20,000 each claimant.
