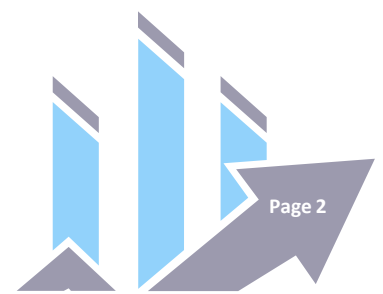

1 Introduction

- 1.1 The “**The Grand Prize League**” (“Promotion”) will be held by CapitalXtend (“Company”), starting from the 1st of July, 2026 and ending on the 31st of August, 2026 (17:00 EEST), included (“Promotion Period”).
- 1.2 To participate in this Promotion, all Clients must agree to the Terms and Conditions (“T&Cs”) of the current document.

2 Participation criteria

- 2.1 The Promotion shall be available to all new and existing clients, including those under Introducing Brokers.
- 2.2 The Promotion will only be available to Fully Approved Clients.
- 2.3 The Promotion shall be applicable to only the following Trading Account types:
 - MT4 / ECN,
 - MT4 / ECN (Swap - free)
 - MT4 / Standard
 - MT4 / Standard (Swap - free)
 - MT4 / Pro ECN,
 - MT4 / Pro ECN (Swap - free)
 - MT5 / ECN,
 - MT5 / ECN (Swap - free)
 - MT5 / Pro ECN,
 - MT5 / Pro ECN (Swap - free)
- 2.4 The Minimum Deposit required to participate in the Promotion equals to **500 USD**.
- 2.5 Only 1 Trading Account is eligible to participate.



2.6 Participants may withdraw funds during the contest. However, doing so will decrease their Net Deposit. If the Net Deposit falls below the minimum requirements of a tier, the participant will no longer be eligible to win the prize.

3 Promotion Specifications

3.1 The Promotion is tier-based and rewards participants according to the total amount deposited during the Promotion Period. Participants will compete **within the Tier they qualify for**, based on their total deposited amount.

To be eligible for participation Clients should:

- a. Have a **Verified Account**.
- b. Be residents of **Pakistan**.
- c. Make the **Minimum Deposit** required during the Promotion Period.

3.2 The minimum deposit required to participate in the Promotion and enter **Tier 3 is USD 500**. Participants may advance to higher Tiers once their total deposited amount exceeds the maximum threshold of the current Tier. Deposits made during the promotion period will be counted cumulatively.

3.3 Winning Conditions:

Within each Tier the participants will be ranked based on:

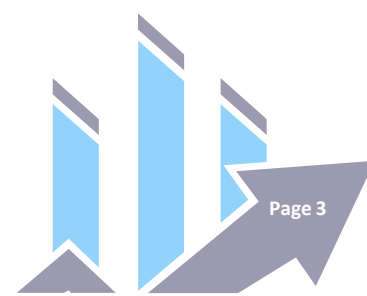
- **Highest Net Deposit**
- **Highest Traded Volume**

**The participant with the Highest Net Deposit and Highest Traded volume at the end of the Promotion Period within each Tier will be declared the winner of that Tier.*

Tier 2	>\$1000	5 Lots	iPhone 16Pro
Tier 3	>\$500	3 Lots	Samsung Curved LED TV

3.4 Each participant is eligible to win **only the prize corresponding to the Tier they qualify for**.



- 3.5** The winners will be announced on the official social media pages of CapitalXtend and will be contacted within 10 days after the promotion period ends.

4 Additionally

- 4.1** Transfer(s) of funds between accounts are not considered as new deposit(s) for the purposes of this Promotion.
- 4.2** Cryptocurrencies, symbols and Indices will not be included in the trading activity calculations.
- 4.3** The *The Grand Prize League* cannot be combined with any other Promotion held by the Company or the Cashback Reward Campaign. Clients who choose to participate in the Promotion will be immediately disqualified from any Promotion held by the Company. Similarly, by joining another Promotion held by the Company, the Client will be immediately disqualified from *The Grand Prize League* Promotion.
- 4.4** The Client consents that the Company may announce their Promotion participation details publicly on the Website and/or any upcoming interview relevant to the Promotion, for promotional purposes.
- 4.5** In the event of a duplicate registration (i.e. two or more unique Client IDs with the same name, email or phone number), only the first Client ID and Trading Account will be eligible to join the Promotion and receive any of the Prizes listed on **Table 1**.
- 4.6** The Company has the right to disqualify any Client if it has reasons to believe that the Client has misused the T&Cs of the Promotion or has used fraudulent means to participate in the Promotion.
